APPLICATION

On March 19, 2014, the Court issued a minute order in *Jewel v. NSA*, C 08-04373 and *First Unitarian Church of Los Angeles v. NSA*, C 13-03287, *Jewel* Doc. #200, providing in part: “Regarding the Government’s compliance with this Court’s prior preservation order in *Jewel*, the Court hereby issues the following briefing schedule.” At the March 19, 2014 conference, reference was also made to the *Shubert* case, in which this Court (Judge Walker) entered another preservation order. *See* MDL 06-cv-1791 Doc. #393, Nov. 6, 2007.

In light of the substantial similarity of the preservation issues in the *Shubert* and the *Jewel* cases, and for the sake of efficient judicial resolution of these issues, the *Shubert* plaintiffs respectfully request that the Court amend its minute order to require briefing “Regarding the Government’s compliance with this Court’s prior preservation orders in *Jewel* and in *Shubert*,” with the same briefing schedule as previously set forth (Government’s brief, May 9; Plaintiffs’ briefs May 30; Government reply, June 13).

The Government **consents** to this request.
