Japan Wins Support From 4 Nations To Join Pacific Trade Talks

TOKYO (Nikkei)--Japan has so far secured the consent of Brunei, Vietnam, Peru and Chile to join negotiations for the Trans-Pacific Partnership free trade agreement, making strides in its effort to win approval from all nine partner nations, The Nikkei has learned.

In Japan's attempt to convince the remaining five nations, receiving a nod from the biggest partner, the U.S., is expected to be the toughest challenge.

Negotiating teams of officials from the economy, foreign affairs, agricultural and other ministries visited Peru on Tuesday and Chile on Wednesday. Both nations basically welcomed Japan's participation in the talks.

Earlier, negotiators visited Vietnam on Jan. 17 and Brunei two days later to win support.

Japan will hold advance consultations with Singapore and Malaysia next month. In February or March it will begin such talks with agricultural powerhouses Australia and New Zealand, which are both likely to pressure Japan to open its agriculture market further.

The final and biggest hurdle will be the U.S., since the White House needs to receive Congress' go-ahead before launching trade talks with other nations.

Japan and the U.S. are expected to kick off advance consultations next month, with the focus to be on Japan opening its auto and agricultural markets. It is expected to take around three months for Congress to grant approval after the

administration signals its intent to enter trade talks with Japan. If the White House notifies Congress at the end of March or in April, Japan could actually join the TPP negotiating table in June or July.

Along with negotiating with partner nations, Prime Minister Yoshihiko Noda still needs to face internal opposition within the ruling Democratic Party of Japan. He has managed to cajole former Farm Minister Masahiko Yamada and other naysayers so far by claiming that "a final decision has not been made." He will eventually have to confront them in order to make an official announcement.

Government officials consider Noda's likely visit to the U.S. in April a critical point in the process.

"It would be perfect if the prime minister explains the decision to join the TPP and President Barack Obama heralds the move," says a METI official.



Kan pushes opening of Japan at Davos, calls for FTA with EU Sunday 30th January, 08:42 AM JST DAVOS, Switzerland —

Prime Minister Naoto Kan on Saturday called for the launch of free trade talks with the European Union this year in an address at one of the world's most influential economic gatherings in the Swiss resort of Davos.

Kan's speech at the annual meeting of the World Economic Forum focused on two themes —the opening up of Japan and the importance of reinforcing social bonds.

Kan explained his belief that accelerating the drive for further opening Japan's doors to the rest of the world will serve as a catalyst to overcome its long economic stagnation and social unease.

But he said, "At the same time, forging new connections between individuals is needed so that the opening of the nation will not bring about rupture among people."

He said that 2011 will be what he termed the "third opening of Japan," following one about 150 years ago when it started to modernize by adopting Western ideas and another after World War II when it followed the path of democracy and a free economy.

In pursuing this goal, Kan said it is imperative for Japan to forge free trade agreements with more countries.

"We also very much look forward to beginning negotiations this year with the EU," Kan said.

He also told the audience of business leaders and policymakers that Japan will decide whether to join talks for a U.S.-backed regional free trade agreement known as the Trans-Pacific Partnership by around June.

At home, there are concerns over an expected huge influx of cheaper agricultural products if Japan advances trade liberalization.

But Kan reiterated his position that the promotion of free trade and making the country's agriculture more internationally competitive could go hand in hand, especially given that Japanese food is starting to be recognized in other countries as delicious and safe.

He introduced one of his mottos that the role of politics is to aim for "a society with the least unhappiness."

"Happiness and prosperity are to be pursued by free individuals based on their own values and ideals," he said.
"Politics, which is among other things an exercise of authority, should not intervene in this process."

Instead, he said the main role of politics must be to implement steps to help eradicate the causes of misfortune and disparities in society.

To maintain or create new social bonds, Kan said he has placed "employment at the center of Japan's national policies not only from an economic but also from a social aspect" since he has been in office since last June.

The five-day meeting began Wednesday with the participation of political, business and academic leaders from all over the world.

Kan is scheduled to return to Tokyo on Sunday afternoon.




