
The use of exigent letters has been the standard operating procedure for CAU prior to my arrival to the Unit. However, the exigent letters were utilized by CAU as a "promissory note." During his testimony before the OIG, Glenn Rogers, the former CAU Unit Chief defended the use of exigent letters during his tenure (beginning 2003 to end of 2004) as being utilized in exigent circumstances. However, from what I eventually learned after being in CAU for some time, was that





the exigent letters were used as a "promissory note" advising hat an NSL or a subpoena would be forthcoming. Most of the exigent letters in connection with the spring 2005 audit were utilized as such - a promissory note that legal authority would be forthcoming once received from the requesting entity (field offices and CTD operational units). Please note, that the spring 2005 audit revealed that CAU was unable to collect the appropriate NSLs and subpoenas from the requesting entities.


