Last week we advised DOJ that the revised NSL reports were delivered to the DAG's office the last week in February. Today, DOJ advised that they received one revised report for NSLs issued pursuant to 18 USC 2709 (period covering the 1st half of 2005). They've asked why the computer glitch didn't effect the #s for NSLs issued under the other authorities (15 USC 1681u and 12 USC 3414(a)). If we are certain that only the 2709 #s needed to be re-submitted, they will go ahead and finalize the reports, but asked us to confirm.

NSLB - please confirm that the revised #s only covered 18 USC 2709 NSLs. If all three reports were re-submitted, can we provided OIPR with a copy directly?

DOJ has also asked if we have finalized our NSL #s for the 2nd half of 2005. Please advise.

Once the Patriot Act is signed (this Thurs), we will have additional public reporting requirements, so DOJ would like to be current.
