On 22 February, the SSCI FAX'd a letter, dated 17 February, from Sen. Rockefeller (SSCI's Vice Chairman) to the Director. Attached to Sen. Rockefeller's letter was a list of **17 questions that seek detailed answers regarding NSLs.**

At this point, it does not appear that we'll be required to submit written answers *per se*. Instead, as the events have now unfolded, it appears that **GC Caproni will travel to The Hill for a briefing, tentatively scheduled for 8 March**, during which she'll be expected to address the questions with detailed, focused answers for **SSCI Members**.
