forcign intelligence case if the material sought. relates to a United States person. There is no "FI&A-derived" impediment. to the use of documents ob tained pursuant to such orders. C. (U//FOUO) Approval Requirements (U//FOUO) All requests for FISA business record orders be must submitted to DOJ Office of Intelligence (OI)through FISAMS. Requests classified up to sccret/collateral will be submitted through FISAMS On FBINET. Requests clas sified Top Secret and/or &CI are s ubmitted through FISAMS on &CION. Field Offices not having SC IO N access must prepare a pape reopy of the request form. route it for appropriate signatures and secure fax the request. form to the MBINQ substantive Unit handling the request. The substantive unit will the request into FISAM 8 on SCION. In Field Offices not having &CION access, paper Top Sceret (TS) of and/or Special. Compartmentalized Information (SCI) requests for business records must be signed by the CDC. ASAC and the SAC.

D. (li) Duration of Approval

(U) Duration is established by the court order.

E. (U) Notice and Reporting Requirements

(U) There are no special notice or reporting requirements.
