## **CEA APPLAUDS USTR'S NEW INTERNATIONAL IP INITIATIVE**

Initiative Will Help Combat Counterfeiting and Unlawful Commercial Piracy

Arlington, Va., October 23, 2007 – The Consumer Electronics Association (CEA) today applauded the United States Trade Representative's (USTR) Anti-Counterfeiting Trade Agreement with a group of key trading partners. The following statement can be attributed to Sage Chandler, senior director of international trade:

"CEA applauds today's announcement by USTR on the intent to negotiate a Free Trade Agreement on intellectual property rights (IPR). The announcement is being made in conjunction with several key governments including Mexico, Canada, Japan, the European Union, Switzerland and New Zealand.

"Counterfeit products cost the consumer electronics (CE) industry millions of dollars every year. This new initiative launched today will not only help combat unlawful commercial piracy, but will bring law enforcement officials into closer communication. The sharing of information and cooperation between enforcement authorities, including Customs and other relevant agencies, is an imperative step to reach the goal of a common standard for IPR enforcement.
