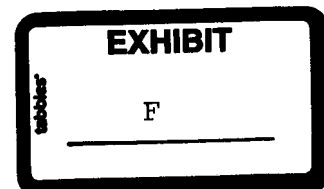

As per that agreement, the subpoena response deadline has been extended to March 9, 2009.

On or around January 16, 2009, the operator of the Blogger site to which the domain name [www.uptownupdate.com](http://www.uptownupdate.com) points received an e-mail from Google informing him/her that identity information regarding the site's operator was subpoenaed in *Fix Wilson Yard, Inc., et al. v. City of Chicago, et al.*, Circuit Court of Cook County, Illinois, Case number 08 CH 45023. Google informed the account holder that he/she had until 5:00 PT on February 4, 2009, to provide Google with a copy of a formal objection letter or motion to quash.

This agreement specifically includes an agreement that these site operators need not provide Google with any formal objection until that time. Accordingly, Google should not comply with the subpoena seeking the identities of the operators of [www.uptownupdate.com](http://www.uptownupdate.com) and [www.whatthehelen.com](http://www.whatthehelen.com) until at least March 10, 2009.




