**Re: Order Indefinitely Staying Subpoenas Seeking Information About
Blogger.com Sites at www.uptownupdate.com and www.whatthehelen.com**

To Whom It May Concern:

This letter is to inform you that on July 9, 2009, a court order was entered indefinitely staying the subpoenas served on Google seeking the identity of the operators of two Blogger.com accounts. Please find the order attached. The order provides that the subpoenas may only be enforced if a future court order is obtained. Accordingly, Google should not comply with the subpoenas unless otherwise ordered by the court.

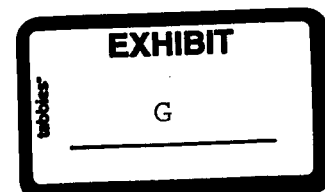
