This letter constitutes an appeal under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, and is submitted by the Electronic Frontier Foundation ("EFF") on behalf of its client, Sophia Helena In 't Veld, a citizen of the Netherlands and member of the European Parliament. Ms. In 't Veld appeals an initial determination rendered by the Federal Bureau of Investigation ("FBI") on December 18, 2007 (attached hereto) in response to a request for records submitted on October 17, 2007 (also attached hereto).

In her request, Ms. In 't Veld sought all records about herself within the consolidated and integrated terrorist watch list maintained by the Terrorist Screening Center ("TSC"). According to the Bureau's determination letter, however, "to promptly respond to requests, we concentrate on identifying main files in the central records system at FBI Headquarters. No records responsive to your FOIPA request were located by a search of the automated indices." Ms. In 't Veld appeals this determination on the grounds that the FBI has not searched the system of records most likely to contain the requested information.

It is clear that the FBI does not maintain the records requested by Ms. In 't Veld in its Central Records System. According to a 2005 Federal Register notice published by the FBI:

The TSC became operational on December 1, 2003 and is charged with consolidating and maintaining the U.S. government's terrorist watch list. In fulfilling its mission, the TSC collects and maintains records about individuals ... that are subject to the requirements of the Privacy Act. These records were previously covered by the FBI Central Records System (Justice/FBI-002) and upon the effective date of this notice they will be part of the Terrorist Screening Records System (TSRS), Justice/FBI-019.

The notice subsequently became effective on December 2, 2005,² and the FBI has maintained watch list records in the Terrorist Screening Records System ever since.³ Thus, we believe that the Terrorist Screening Records System — and not the Central Records System — is the likely location of the records that Ms. In 't Veld seeks.

This is in further response to your October 17, 2007 Freedom of Information Act (FOIA) request, Request No. 1103554, in which you have sought access to "all records concerning Ms. [Sophia Helena] In't Veld (including but not limited to electronic records) in the consolidated and integrated terrorist watch list maintained by the Terrorist Screening Center."

After reviewing the initial correspondence in this case, we have determined that due to an administrative misinterpretation of your request, the FBI's December 18, 2007 "no records" response was sent in error. In responding to your request, the FBI interpreted the request as a general first-party request rather than a specific request for records concerning Ms. In 't Veld located in the Terrorist Screening Center Database ("TSDB"). To the extent that your October 17, 2007 FOIA request has sought records maintained by the FBI concerning Ms. In't Veld "in the consolidated and integrated terrorist watch list maintained by the Terrorist Screening Center," please be advised that the U.S. Government can neither confirm nor deny whether a particular person is on any terrorist watch list, including the TSDB. Maintaining the confidentiality of government watch lists is necessary to achieve the counterterrorism objectives of the U.S. Government. If the U.S. Government revealed who has or has not been listed on any government watch list, terrorists would be able to take actions to avoid detection by government authorities. Thus, pursuant to FOIA Exemptions 2 and 7(E), 5 U.S.C. §§ 552(b)(2) and (b)(7)(E), the FBI can neither confirm nor deny the existence of records which would tend to indicate whether a particular person is or ever was listed on any government terrorist watch list, including but not limited to, the TSDB. Please note that this is a standard notice which the FBI has issued in response to requests for documents concerning any individual on any government watch list. This response should not be taken as an indication that records do or do not exist with respect to your particular request.
