I hope you are having a great New Year so far.... Our system is almost ready to pilot so let's get this started!

A few things, I have attached the latest version of the Interstate Photo System Facial Recognition Pilot (IPSFRP) Technical Specification document that outlines the new Types of Transactions, mandatory codes, and essential email address (this is a CJIS Wide Area Network [WAN]) remind your vendor/programmers that all transactions must go over the CJIS WAN not over the Internet. We have had trouble with other states trying to connect over the Internet.

Once your programmers have a chance to review the Tech Spec and do the minor programming we will try running some test records.

On our end, we will need your CJIS WAN public IP address/ORI/email address that HI will be using to send/receive the FR transactions so we can open our firewalls here.

Anyway, if you or your programmers have any question, feel free to give me a shout. We look forward to piloting with HI.
