
SUBJECT: Intelligence Oversight Board Reporting Criteria

Attached at Tab A are revised requirements and guidelines for reporting to the Intelligence Oversight Board (IOB) of the President's Foreign Intelligence Advisory Board (PFIAB), pursuant to Executive Order 12863. As described in my memorandum on August 18, 2006, these revised reporting criteria are part of an ongoing effort to enhance IOB reporting procedures. In the near future I will provide for your review proposed amendments to Executive Order 12863 intended to clarify the procedural and substantive aspects of IOB reporting and to reflect the establishment of the Office of the Director of National Intelligence (O/DNI). The attachment replaces an earlier version of these guidelines distributed to your senior counsel and inspectors general by the O/DNI.

The IOB reporting requirements pertain to activities that may be unlawful or contrary to executive order or presidential directive. These requirements operate independently of the obligation of heads of departments and agencies to provide timely notification to the Director of National Intelligence (DNI) of significant or highly sensitive matters related to intelligence activities. Early notice of such activities including, for example, the unauthorized disclosure of protected information or intelligence activities likely to impact negatively on U.S. policies and relationships abroad, will enable the DNI to fulfill his statutory commitments to the Congress as well as his responsibilities as the President's principal advisor for intelligence matters. At his discretion, the DNI may refer such matters to the PFIAB for review

Tab A Revised IOB Reporting Criteria

UNCLASSIFIED//FOR OFFICIAL USE ONLY**Intelligence Oversight Board (IOB) Reporting Criteria**

1. **Purposes.** This updates the requirements and guidance for reporting to the IOB pursuant to Executive Order 12333 Section 1.7(d), Executive Order 12863, and the August 18, 2006 memorandum from the Assistant to the President for National Security Affairs. This guidance applies to all IOB reports made on or after April 1, 2007 and supersedes all guidance issued by previous IOBs.
2. **Authorities.**
 - Section 2.4 of Executive Order 12863 states that Inspectors General (IG) and General Counsel (GC) of the Intelligence Community (IC), "shall report to the IOB, at least on a quarterly basis and from time to time as necessary or appropriate, concerning intelligence activities they have reason to believe may be unlawful, and at least on a quarterly basis, and from time to time as necessary and appropriate, matters that they have reason to believe may be contrary to Executive order or Presidential directive."
 - Sections 1.7(d) and (h) of Executive Order 12333 state that the heads of departments and agencies with organizations in the Intelligence Community or the heads of such organizations, as appropriate, shall, "report to the Intelligence Oversight Board and keep the DNI appropriately informed, concerning any intelligence activities of their organizations that they have reason to believe may be unlawful or contrary to Executive order or Presidential directive" and "instruct their employees to cooperate fully with the IOB."
 - Section 3.4(e) of Executive Order 12333 defines "intelligence activities" as "all activities that agencies within the Intelligence Community are authorized to conduct pursuant to this Order."
 - The August 18, 2006 memorandum from the Assistant to the President for National Security Affairs outlines new procedures and instructs that they be carried out consistent with reporting criteria developed by the IOB and DNI. Based on the DNI's statutory obligation to ensure compliance with the Constitution and laws of the United States by the Central Intelligence Agency and to ensure such compliance by other elements of the intelligence community through the host executive departments, the ODNI will assume an enhanced role in the IOB review process, including analyzing guidelines and reports, identifying trends or patterns warranting further action, and ensuring matters deemed appropriate by the President are carried out.

3. Reports to the IOB.

(a) **Immediate Reports.** In accordance with Section 2.4 of Executive Order 12863, it shall be necessary and appropriate for heads of departments and agencies with organizations in the IC to report through IGs and GCs of the IC any specific issue identified in either of the categories below, usually not later than seven calendar days after becoming aware of an intelligence activity they have reason to believe may be unlawful.

- Particularly serious potential criminal violations;
- Matters otherwise reportable under E.O. 12863 that will be reported to Congressional oversight committees.

(b) **Quarterly Reports.** GCs and IGs of the IC shall submit quarterly reports to the IOB for all other issues not reported pursuant to subparagraph (a) above, that they have reason to believe may be unlawful or contrary to Executive order or Presidential directive.

- Items that are potentially unlawful or contrary to Executive orders or Presidential directives and reported to the Congressional intelligence oversight committees shall be contemporaneously reported to the DNI and IOB. This includes, but is not limited to, congressional notifications and general reports required by statute known as Congressionally Directed Actions.
- Copies of Inspector General Semi-annual reports shall also be submitted to the DNI and IOB without regard to whether those reports are likewise provided to Congress.
- Reports filed with the Attorney General or designee pursuant to the *Memorandum of Understanding on Reporting of Information Concerning Federal Crimes (1995)* that involve intelligence activities that may be unlawful, should also be reported to the DNI and IOB.

(c) **Schedule for Quarterly Reports.** Agencies should submit four copies of narrative reports to IOB General Counsel pursuant to the following schedule:

CY Jan – Mar items are due not later than the last business day in April;

CY Apr – Jun items are due not later than the last business day in July;

CY Jul – Sep items are due not later than the last business day in October; and

CY Oct – Dec items are due not later than the last business day in Jan of the next year.

Copies of these reports shall be provided by the IOB to the ODNI for the purpose of providing the IOB with an analysis of the severity of reported items, trends or patterns of recurring concerns, how the IC elements are addressing those items and concerns, and actions taken or proposed by the DNI to address systemic issues identified in IC reports to the IOB.

(d) Format for Immediate and Quarterly Reports. Reports should include an explanation of the activity at issue, any extenuating or mitigating circumstances, and any action being taken in response. Reports should not be delayed because additional factual or legal research may be required. Moreover, the fact that an organization concludes on balance, that an activity is lawful does not relieve an organization from reporting questionable matters as to which legality may be argued. There is a preference for written reports; however, in fast-breaking situations, oral reports can be made to the IOB General Counsel. The IOB Reporting Summary Sheet, included as an attachment to these guidelines, shall also accompany written reports.
