#### DECLARATION OF JOHN F. HACKETT

- I, John F. Hackett, declare the following to be true and correct:
- 1. I am the Director of the Information Management Office (IMO) for the Office of the Director of National Intelligence ("ODNI" or "Agency"). In this capacity I am the final decision-making authority for the IMO, which receives, processes, and responds to requests for ODNI records under the Freedom of Information Act (FOIA), 5 U.S.C. 552.
- I make the statements herein on the basis of personal knowledge, as well as on information acquired by me in the course of performing my official duties.
- 3. By facsimile dated February 25, 2008, plaintiff Electronic Frontier Foundation submitted a FOIA request to ODNI for records of all reports submitted by the Office of the Director of National Intelligence to the Intelligence Oversight Board ("IOB") pursuant to Section 2.4 of Executive Order 12863 since April 2005. ODNI received the request on February 25, 2008. (A copy of plaintiff's February 25, 2008 request letter is attached hereto as Exhibit A.) Plaintiff did not request expedited processing.
- 4. Pursuant to ODNI regulation, all requests are processed on a "first-in, first-out" basis unless a request for expedited processing is received and granted. See 32 C.F.R. § 1700.12

- (2008). Therefore, plaintiff's request was assigned number DF-2008-00029 and placed in our normal processing queue. ODNI does not have any record of providing the plaintiff with a written acknowledgement of plaintiff's FOIA request. When this inadvertent oversight was discovered ODNI provided a written status update to the plaintiff dated August 13, 2009. (A copy of ODNI's August 13, 2009 letter is attached hereto as Exhibit B.)
- 5. By facsimile dated June 19, 2009 plaintiff submitted a second FOIA request to ODNI. In this request, plaintiff requested reports submitted to the IOB pursuant to Executive Order 12863 through February 29, 2008, and also requested all records concerning the ODNI's activities under Executive Order 13462 from February 29, 2008 to the present. This includes reports, assessments, reviews, instructions, guidelines, and submissions to or communications between the ODNI and the IOB and/or the President's Intelligence Advisory Board ("PIAB"). (A copy of plaintiff's June 19, 2009 request letter is attached hereto as Exhibit C.) Plaintiff did not request expedited processing. Therefore, plaintiff's request was assigned number DF-2009-00083 and placed in our normal processing queue.
- 6. By letter dated June 29, 2009, ODNI acknowledged receipt of plaintiff's request. (A copy of ODNI's June 29, 2009 letter is attached hereto as Exhibit D.)

### Processing and Current Status of Plaintiff's Requests

7. A search was conducted in the Offices of the General Counsel and Inspector General for records responsive to plaintiff's first request for ODNI IOB reports and 15 documents, totaling 18 pages, was located. ODNI is currently processing those records for release, which includes consulting with another government entity, and anticipates being able to provide a response to the plaintiff by December 15, 2009.

- 8. Searches for records responsive to plaintiff's second request are currently being performed in the Offices of the General Counsel and Inspector General. To date, all of the responsive IOB reports have been located, consisting of 10 documents, totaling 26 pages. The remainder of the plaintiff's request is very broad and requires much more time to locate responsive records. Plaintiff has requested all records concerning the DNI's activities pursuant to Executive Order 13462, including reports, assessments, reviews, and communications with the IOB. In order to process this portion of plaintiff's request, individuals that are reasonably likely to maintain responsive material are performing searches of their records. We anticipate having to review thousands of pages of documents to determine if they are responsive and process them for the application of FOIA exemptions.
- 9. We anticipate completing the processing of the ODNI IOB reports responsive to plaintiff's second request by December 15, 2009. However, it will require significantly more time to complete the processing of the remainder of plaintiff's second request. Individuals in the Office of General Counsel and the Office of the Inspector General are currently searching their records, including electronic records, for responsive documents. Given the breadth of plaintiff's request, these searches are extremely time-consuming. In addition, based on an initial assessment of some of the records located thus far, it is clear that many of them contain highly sensitive classified information that will require a classification review and inter-agency consultations and referrals.
- 10. We anticipate our search for documents responsive to plaintiff's second request to be completed in approximately two weeks. Based on search results received thus far, we anticipate that thousands of pages of classified and unclassified documents will be provided to the IMO for review to determine if they are responsive to plaintiff's request and to process them for possible disclosure.

11. The potential volume of the responsive records and the sensitivity of the information in them will require adequate time for careful processing. We anticipate being able to complete processing of this portion of plaintiff's second request by March 31, 2010. However, we are willing to discuss this timeline with the plaintiff and to process first those records that are a priority for the plaintiff.

12. Many of the records located so far, including IOB reports and other records responsive to plaintiff's request, contain sensitive classified information. The existence of classified material contributes significantly to the complexities attendant to processing a FOIA request. Responsive documents that contain classified information must undergo an additional time-intensive review to ensure that currently and properly classified information is appropriately protected in accordance with Executive Order 12958, as amended. Such review also includes a page-by-page and line-by-line review of the documents to determine which, if any, FOIA exemptions may apply and which information can be disclosed. In light of the sensitive nature of classified information, potentially responsive material must also be reviewed by offices and agencies with equities in the documents to ensure that no improper disclosures are made. Such offices and agencies need sufficient time to perform a careful and thorough review of their information. It is vital to the national security that the review of classified information is done carefully and deliberately.


We are seeking copies of all reports submitted by the Office of the Director of National Intelligence to the Intelligence Oversight Board ("IOB") pursuant to Section 2.4 of Executive Order 12863. That section provides, in pertinent part, as follows:

Inspectors General and General Counsel of the Intelligence Community, to the extent permitted by law, shall report to the IOB at least on a quarterly basis and from time to time as necessary or appropriate, concerning intelligence activities that they have reason to believe may be unlawful or contrary to Executive order or Presidential directive.

We seek such reports submitted to the IOB since April 2005,

#### Request for News Media Fee Status

EFF asks that it not be charged search or review fees for this request because EFF qualifies as a representative of the news media pursuant to the FOIA and 32 C.F.R. § 1700.2(h)(4). In requesting this classification, we note that the Department of Homeland Security, National Security Agency, and Department of State have recognized that EFF qualifies as a "news media" requester, based upon the publication activities set forth below (see DHS stipulation, NSA letter, and Sate Department letter attached hereto). We further note that the U.S. Court of Appeals for the D.C. Circuit has stressed that "different agencies [must not] adopt inconsistent interpretations of the FOIA." Al-Fayed v. CIA, 254 F.3d 300, 307 (D.C. Cir. 2001), quoting Pub. Citizen Health Research Group v. FDA, 704 F.2d 1280, 1287 (D.C. Cir. 1983).

EFF is a non-profit public interest organization that works "to protect and enhance our core civil liberties in the digital age." One of EFF's primary objectives is "to educate the press, policymakers and the general public about online civil liberties." To accomplish this goal, EFF routinely and systematically disseminates information in several ways.

First, EFF maintains a frequently visited web site, http://www.eff.org, which received 46,682,194 hits in July 2007 — an average of 62,744 per hour. The web site reports the latest developments and contains in-depth information about a variety of civil liberties and intellectual property issues.

EFF has regularly published an online newsletter, the EFFector, since 1990. The EFFector currently has more than 77,000 subscribers. A complete archive of past EFFectors is available at http://www.eff.org/effector/.

Furthermore, EFF publishes a blog that highlights the latest news from around the Internet. DeepLinks (http://www.eff.org/deeplinks/) reports and analyzes newsworthy developments in technology. It also provides miniLinks, which direct readers to other news articles and commentary on these issues. DeepLinks had 510,633 hits in July 2007.<sup>4</sup>

In addition to reporting hi-tech developments, EFF staff members have presented research and in-depth analysis on technology issues in no fewer than eighteen white papers published since 2002. These papers, available at http://www.eff.org/wp/, provide information and commentary on such diverse issues as electronic voting, free speech, privacy and intellectual property.

EFF has also published several books to educate the public about technology and civil liberties issues. Everybody's Guide to the Internet (MIT Press 1994), first published electronically as The Big Dummy's Guide to the Internet in 1993, was translated into several languages, and is still sold by Powell's Books (http://www.powells.com). EFF also produced Protecting Yourself Online: The Definitive Resource on Safety, Freedom & Privacy in Cyberspace (HarperEdge 1998), a "comprehensive guide to self-protection in the electronic frontier," which can be purchased via Amazon.com (http://www.amazon.com). Finally, Cracking DES: Secrets of Encryption Research.

Wiretap Politics & Chip Design (O'Reilly 1998) revealed technical details on encryption security to the public. The book is available online at http://cryptome.org/cracking -des.htm and for sale at Amazon.com.

Most recently, EFF has begun broadcasting podcasts of interviews with EFF staff and outside experts. *Line Noise* is a five-minute audio broadcast on EFF's current work, pending legislation, and technology-related issues. A listing of *Line Noise* podcasts is available at feed://www.eff.org/rss/linenoisemp3.xml and feed://www.eff.org/rss/linenoiseogg.xml. These podcasts were downloaded more than 2,600 times from EFF's web site in July 2007.

# Request for a Public Interest Fee Waiver

EFF is entitled to a waiver of duplication fees because disclosure of the requested information is in the public interest within the meaning of 5 U.S.C. § 552(a)(4)(a)(iii) and 32 C.F.R. § 1700.6(b)(2). To determine whether a request meets this standard, the agency determines whether "[d]isclosure [of the requested information] is likely to contribute significantly to public understanding of the operations or activities of the United States government," and whether such disclosure "is not primarily in the commercial interest of the requester." 32 C.F.R. § 1700.6(b)(2). This request clearly satisfies these criteria.

First, the agency's submission of reports to the IOB clearly concerns "the operations or activities of the government." 32 C.F.R. § 1700.6(b)(2).

Second, disclosure of the requested information will contribute to a public understanding of government operations or activities. 32 C.F.R. § 1700.6(b)(2). EFF has requested information that will shed light on the agency's interpretation of laws governing intelligence activities, and how well it conforms to those laws. This information will contribute not only to EFF's understanding of the agency's interpretation and use of legal authority, but to the understanding of a reasonably broad audience of persons interested in the subject. EFF will make the information it obtains under the FOIA available to the public and the media through its web site and newsletter, which highlight developments concerning privacy and civil liberties issues, and/or other channels discussed more fully above.

Finally, the disclosure will "contribute significantly" to the public's knowledge and understanding of how the agency seeks compliance with laws governing intelligence activities. 32 C.F.R. § 1700.6(b)(2) (internal quotation marks omitted). Disclosure of the requested information will help inform the public about the agency's actions, as well as contribute to the public debate about how intelligence activities should be conducted.

Furthermore, a fee waiver is appropriate here because EFF has no commercial interest in the disclosure of the requested records. 32 C.F.R. § 1700.6(b)(2). EFF is a 501(c)(3) nonprofit organization, and will derive no commercial benefit from the information at issue here.

Defendant DHS will continue to regard Plaintiff EFF as a "representative of the news media" absent a change in circumstances that indicates that EFF is no longer an "entity that is organized and operated to publish or broadcast news to the public." 6 C.F.R. § 5.11(b)(6).
- 2. Accordingly, the parties herewith agree to the dismissal of Plaintiff EFF's Second Cause of Action, related to EFF's status as a "representative of the news media."
- The parties further agree that each will pay its own fees and costs for work on the dismissed claim.
