

legally perform itself, in contravention of law, policy or
regulation. The complaint was originally forwarded to the
Inspector General, U.S. Air Force. However, as the
complaint involved a member of the U.S. Marine Corps, the
complaint was forwarded to the Marine Corps Inspector
General. Their review is ongoing. During the course of
the investigation by the Air Force Inspector General, it
appeared that the investigation might have inappropriately
compromised the identity of the complainant in
contravention of Inspector General procedures. The DoD
Hotline investigated this issue and found no impropriety.

(U) We received a DoD Hotline complaint of
intelligence oversight irregularities at the U.S. Army
Intelligence and Security Command (INSCOM). The complaint
alleged that INSCOM personnel may have violated policy and
procedure through the conduct of surveillance of U.S.
persons by monitoring demonstrations against the World

reported that the assertions and allegations in the
National Guard article were all investigated in a prior
investigation that was completed in December 2000. Actions
were taken to address deficiencies noted. This issue is
considered closed.

for investigation. The IG, JFCOM, issued its report on
December 21, 2000, and concluded that the allegations were






